## SINGLE SESSION TICKETS NOW ON SALE FOR 2013 WCHA FINAL FACE-OFF PLAYOFF CHAMPIONSHIP AT RIDDER ARENA IN MINNEAPOLIS MARCH 8-9; ALL-SESSION TICKETS ALSO STILL AVAILABLE

MADISON, Wis. – Single session tickets for the women's Western Collegiate Hockey Association's FINAL FACE-OFF are on sale beginning Monday, March 4. The playoff championship tournament will be held at Ridder Arena in Minneapolis, Minn., this Friday and Saturday, March 8-9, and involves three of the top-rated team in the country, including unbeaten and defending national champion Minnesota.

Two semi-finals will be played on Friday (March 8) when No. 3 seed North Dakota (25-10-1) faces No. 2 seed Wisconsin (23-9-2) at 4:07 pm CT followed by No. 5 seed Ohio State (19-14-3) against No. 1 seed Minnesota (36-0-0) at 7:07 pm CT.

Friday's winners will then play for the league championship on Saturday (March 9) at 7:07 pm CT. The winner of the WCHA FINAL FACE-OFF receives the league's automatic berth into the NCAA Division 1 Women's Ice Hockey Tournament.
